American Christian Juridical Apologists 1850-1947

Philip Johnson is a visiting lecturer in apologetics at Morling College, New South Wales. He has co-authored several books including *Taboo or To Do?*, *The Cross is Not Enough*, *Beyond the Burning Times*, and *Jesus and the gods of the new age*. Abstract: Public lectures and sermons, as well as books and essays, based on juridical apologetics topics developed as a popular feature of American Christian evangelism for a century following Simon Greenleaf's *The Testimony of the Evangelists*. This essay presents a tabulated list of one hundred and twenty-two juridical apologists in the USA from 1850-1947. Many of those listed have been overlooked in previous discussions. The bulk of the bibliographical data is derived from newspapers which announced apologetic sermons and lectures, summarised them as news items, or published the entire text of the apologist's presentation. The table is prefaced by a brief outline of topical matters which forms embryonic data for an unwritten chapter in the history of this apologetic genre in the USA.

A bio-bibliographical list of ninety-two Christian juridical apologists (1600-2000AD) was published in 2002.¹ Tabulated below are a hundred and twenty-two apologists just in the USA (1850-1947). This genre is characterised by legal reasoning, jural analogies, similes, and metaphors. Some apologists use the common-law tradition's civil standard of proof (balance of probabilities) or the criminal standard (proof beyond reasonable doubt).² Like Simon Greenleaf, some cite legal textbook authorities or case-law. Others use legal rhetoric without technical

standards for proof.³ Apologists include qualified practitioners (lawyers, judges, legal academics) and non-lawyers.

Ross Clifford pointed to several frontiers for research.⁴ William Broughton's (1937-2013) concise narrative suffered from gaps and misunderstandings.⁵ The interest of legal historians in Greenleaf and Francis Wharton may encourage further research.⁶

American apologists from 1850-1947 inherited a British-European tradition which cross-fertilised epistemology, theology, historiography, and jurisprudence. It included Francis Bacon's inductive reasoning, John Locke's empiricism, Thomas Reid's Common Sense Philosophy and Christian-Deist debates about apostolic testimony.⁷

Positive and negative social attitudes toward the prestige of lawyers is pertinent.⁸ US theologians, such as Alvah Hovey (1820-1903), and Shadrach Bowman (1829-1906), cited

Greenleaf.⁹ *The Bible Champion* praised Greenleaf and Francis J. Lamb extravagantly.¹⁰ In the 1940s, unreliable folkloric stories were printed about Greenleaf converting from atheism.¹¹ Juridical rhetoric impressed lay-leaders such as John R. Mott (1865-1955) who opined, "No single event in history is better supported by legal evidence than the resurrection."¹² Newspapers and magazines have played a part in grass-roots communication of juridical apologetics.¹³

Justin Saxby's juxtaposing of Herman Melville's *Bartelby the Scrivener*, Greenleaf's *Testimony* and David Strauss' *Life of Jesus* suggests a literary canvas for doubt and persuasion in nineteenth century America. ¹⁴ Jewish apologists used the jural paradigm in arguments about Jesus' trial. ¹⁵ Jural metaphors surface in T. H. Huxley's agnostic essays. ¹⁶ A reflective study of the intellectual life of those who lost faith and those who converted would be pertinent. ¹⁷

Apologists addressed YMCA meetings, Catholic and Protestant gatherings. Some combined church membership with Freemasonry. Some became politicians or diplomats with affiliations spread between Whigs, Democrats and Republicans. James Pendleton was a pro-Union Southern Baptist, while Henry Wharton was a pro-Confederate Baptist. There were prohibitionist and anti-tobacco campaigners, such as George Gere, Howard Hyde Russell, Liston McMillen, and Wallace Struble. Walter Chandler was an outspoken critic of both the Ku Klux Klan and the maltreatment of Jews. Mordecai Ham was a notorious anti-Semite.

A grass-roots form of juridical apologetics is apparent in letters to editors, as well as sermons and local community talks presented after the Civil War and during upheavals such as the

First World War, Great Depression, and Second World War. ¹⁸ A 1927 Easter pageant used jural analogies for the resurrection. ¹⁹ Helen Edson's novel *A Lawyer's Religion* featured Judge Baldwin who answered questions about Jesus and the gospels. ²⁰ Former attorney Lew Wallace's *Ben-Hur* is part of this social phenomena. ²¹

This bibliography is not exhaustive. It is arranged alphabetically by surname and tabulated in columns: apologist plus birth/death dates, professional status, lecture/sermon/article/book title, authorities cited, as well as year of publication. The entries are footnoted and most refer to lectures published in newspapers or public announcements. There are a hundred and one previously overlooked apologists including twenty-five judges. Over forty clergy are listed, but several had once been lawyers. Nine entries are "unknown" because author identity is uncertain. Twenty-one apologists identified by * were in my earlier study. This bibliography terminates in 1947 marking the centenary of the second edition of Greenleaf's *Testimony*.

Robert Miller, an atheist-lawyer critic of juridical apologetics doubted my estimation that Greenleaf was a "pivotal" figure—by which I meant key, crucial, essential, important—in the genre's development.²² Miller affirms Greenleaf was influential but interprets his apologia as echoing Dutch lawyer-apologist Hugo Grotius.²³ He is puzzled that Greenleaf never cited Grotius, but such puzzlement fades when Greenleaf is understood in historical context as a direct heir to gospel harmonies, Bacon's thought, Reid's Common Sense Philosophy, and eighteenth century debates about testimonial evidence.²⁴ Grotius' theological orthodoxy was considered suspect long before this survey period which may explain why neither Greenleaf nor the other apologists listed

here mention him.²⁵ In the table below Greenleaf was the most cited authority, and footnoted books include page references where he is cited.
